

Privacy policy

This privacy policy applies between you, the User of this Website and Jurassic Bark Harrogate, the owner and provider of this Website. Jurassic Bark Harrogate takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

Please read this privacy policy carefully.

Definitions and interpretation

In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Jurassic Bark Harrogate via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Act 1998;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

UK and EU Cookie Law	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
User or you	any third party that accesses the Website and is not either (i) employed by Jurassic Bark Harrogate and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Jurassic Bark Harrogate and accessing the Website in connection with the provision of such services; and
Website	the website that you are currently using, www.jurassicbarkharrogate.co.uk , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

In this privacy policy, unless the context requires a different interpretation:

1. the singular includes the plural and vice versa;
2. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
3. a reference to a person includes firms, companies, government entities, trusts and partnerships;

4. "including" is understood to mean "including without limitation";
5. reference to any statutory provision includes any modification or amendment of it;
6. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

This privacy policy applies only to the actions of Jurassic Bark Harrogate and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Data collected

We may collect the following Data, which includes personal Data, from you:

1. Name
 2. Contact Information such as email addresses and telephone numbers;
- in each case, in accordance with this privacy policy.

Our use of Data

For purposes of the Data Protection Act 1998, Jurassic Bark Harrogate is the "data controller".

We will retain any Data you submit for as long as we feel is relevant and/or necessary.

Unless we are obliged or permitted by law to do so, and subject to any third party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and / or other companies within our group.

All personal Data is stored securely in accordance with the principles of the Data Protection Act 1998 and updated in accordance with the new GDPR regulations. For more details on security see the clause below (**Security**).

Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

1. internal record keeping;
- in each case, in accordance with this privacy policy.

Third party websites and services

Type of Cookie	Purpose

This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
